##### Emergency Overview

##### Potential Health Effects

Based on animal data, eye contact with Florasulam may cause eye irritation with tearing, pain or blurred vision.

##### Carcinogenicity Information

None of the components present in this material at concentrations equal to or greater than 0.1% are listed by IARC, NTP, OSHA or ACGIH as a carcinogen.

#### 4. First Aid Measures

**Skin contact:** If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20minutes. Call a poison control center or

**Eye contact:** If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

Have the product container or label with you when calling a poison control center or doctor, or going for treatment.

### 5. Fire Fighting Measures

**Inhalation** LC<sub>50</sub>, (4 h): > 6.0 mg/L in rats (Very low toxicity)

Florasulam is a light eye irritant, but not a skin sensitizer in animals.

Application of a single dose of Florasulam to the skin of rabbits resulted in body weight loss. Repeated applications caused skin irritation but no other changes were observed. Ingestion of a single dose of Florasulam by animals caused body weight loss and other nonspecific effects. Repeated dosing produced decreased body weight gain and decreased liver weights when compared to the control group. Long term administration caused body weight loss.

Single exposures of animals to Florasulam by inhalation caused body weight loss and other nonspecific effects. Animal testing indicates that Florasulam does not have carcinogenic, developmental, or reproductive effects. There is a report indicating that Florasulam produced genetic damage in a mammalian cell culture test; however, other tests with Florasulam in bacterial and mammalian cell cultures and in animals did not produce genetic damage. The weight of evidence suggests that Florasulam does not cause genetic damage.

## 13. Disposal Considerations

**Waste Disposal :** Do not contaminate water supply, food or feed by storage or disposal. Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. Treatment, storage, transportation, and disposal must be in accordance with applicable Local regulations.

**Environmental Hazards:** Do not apply directly to water, or areas where surface water is present, or to intertidal areas below the mean high water mark. Do not contaminate water when disposing of equipment washwaters.

allowed by State and local authorities, by burning. If burned stay out of smoke.

**For Fiber Sacks:** Completely empty fiber sack by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into manufacturing or application equipment. Then dispose of sack in a sanitary landfill or by incineration if allowed by State and local authorities.

**For Fiber Drums with Liners:** Completely empty liners by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into manufacturing or application equipment. Then dispose of sack in a sanitary landfill or by incineration if allowed by State and local authorities. If the drum is contaminated and cannot be reused, dispose of in the same manner.

**For Bags Containing Water Soluble Packets:** Do not reuse the outer box or the resealable plastic bag. When all water-soluble packets are used, the outer packaging should be clean and may be disposed of in a sanitary landfill or by incineration, or if allowed by State and local authorities, open burning.
